A TAX DEDUCTION FOR SUPPORTING THE SHOOTING SPORTS???



The Sporting Shooters' Association of Australia (Vic) Ltd have registered three projects with the Australian Sports Foundation (ASF) to enable members, companies and other individuals to donate to the ASF in support of the sport they love and at the same time be eligible for a TAX DEDUCTION!

What is the ASF?

The ASF was established to assist Australian sports fundraise through the corporate sector and the community at large. Donations to the ASF are eligible tax deductions and donors are able to nominate a preferred beneficiary for their gift. The SSAA (Vic) Ltd has three approved projects registered with the ASF; these are Sport Development - #203157, Equipment Purchase - #203156 and Range Upgrade - #203155.

Voluntary donations to the ASF are tax deductible and making a donation is easy.

You need to make your donation to the ASF on the official donation form (right) but you may nominate any or all of the projects that the SSAA (Vic) has registered with them. Donations can be made in one payment together with your membership fee. Donations must be made unconditionally to the ASF and can be split between the projects if you wish. There is a particular emphasis on junior sport in our projects, with two junior scholarships planned and a junior coaching camp. Donations can be made by individuals or by a company.
